Subject: Implementation of Revised MRP Pursuant to GST Rate Reduction (Effective from 22nd September 2025)

Dear Business Partner,

As you may be aware, the Government of India has announced a revision in the GST rates on certain products, effective from 22nd September 2025. In line with this directive, the Maximum Retail Price (MRP) of all affected products must be revised accordingly.

Please note the following important points for your immediate attention and compliance:

#### 1. MRP Revision:

- The GST rate on specified products has been reduced from 12%/18% to 5%.
- o This mandates a proportionate reduction in MRPs with effect from the notified date.
- A detailed list of impacted products is enclosed in Annexure "A".
- Revised MRP stickers will be send along with this letter. These stickers should be applied to all relevant products in your inventory.

## 2. Passing on Benefits:

- o As per legal requirements, the benefit of reduced taxation must be passed on to the end consumer.
- o Trade margins and Input Tax Credit (ITC) entitlements on existing stock will remain unchanged.

### 3. Billing & Inventory:

- o Full ITC will continue to be available on current stock.
- All invoices raised on or after 22nd September 2025 must reflect the revised GST rate and updated MRPs.
- Please ensure that your billing and accounting systems are updated to comply with the revised pricing.

#### 4. Business Continuity:

• We encourage you to maintain regular procurement and inventory levels to ensure seamless supply during this transition.

We appreciate your cooperation in implementing this change and ensuring that the benefit of the GST reduction is passed on promptly to consumers. For any further clarification, please reach out to your respective support team.
